This transfer institution has agreed to accept the specified associate's degree from FCCJ. The FCCJ graduate will be accepted at the junior level, and is required to complete the equivalent of three years of full-time coursework FCCJ and completing the fourth and final year at Regis University. The following chart shows the specific courses that the FCCJ student is required to take to meet the guidelines of the articulation agreement with the transfer institution.

It is very important to make sure that your Program of Study at FCCJ is Associate of Arts or Associate of Science. If you do not plan to transfer to this specific transfer institution, please follow the Program of Study, as specified in the College Catalog.

Upon graduation from Florida Community College, Regis University (RU) will accept coursework from any AA or AS degree towards the BS Public Administration program. Students will complete a minimum of 36 upper-division semester credit hours from Regis University to graduate with a Bachelor of Science Degree in Public Administration.

*This agreement assumes that the student has no course work from this section completed as part of the A.A. or A.S. degree. However, the total number of credit hours that can be transferred to Regis University is 90 semester credit hours.

General Education Notes:

- Please review the Florida Community College Catalog for General Education Requirements (GER).
- CLAST (College Level Academic Skills Test): The CLAST is a graduation requirement for the associate in arts degree at Florida Community College. Passing all four subsets of the CLAST exam, or satisfying a CLAST exemption, is a requirement for meeting the associate of arts degree graduation requirement.
- The state university Foreign Language Requirement does not apply to students transferring to Regis University.
- All General Education courses require a grade of "C" or above.

- Students may complete additional General Education courses, as electives, at Regis University. Students must meet the RU General Education Requirements.

Prerequisite and Elective Notes:

- All prerequisite courses require a grade of “C” or above.
- A major prerequisite course may satisfy both FCCJ General Education Requirements and RU Major Prerequisites. Please review the General Education Requirements and talk with an advisor.
- FCCJ Electives must have the appropriate notation at the end of the course description in FCCJ catalog (AA for Associate in Arts degree, and AS for Associate in Science degree electives).

Other Notes:

- Students must complete the Information Literacy Assessment requirement prior to graduation from FCCJ.
- Qualified students will have earned a grade point average of 2.0 and will have earned an Associate in Arts or Associate in Science degree before transferring.
- No more than 90 semester hours of credit may be transferred toward completion of the degree requirements at RU.
- If you do not plan to transfer to this specific transfer institution, please follow the Program of Study, as specified in the College Catalog.
